

# Swiss Arms Exports from 1998-2018


An increase of 98% since September 11, 2001

# IMPORTERS OF SWISS ARMAMENTS IN 2018


TOP-10 importers in **BLUE** // Belligerent & Human rights violating importers in **RED**

# SWITZERLAND ARMING THE ATOMIC POWERS INDIA & PAKISTAN



## From RWM Italia to Saudi Arabia War Crimes in Yemen war

- In the night of the 8<sup>th</sup> of October 2016 a bomb - apparently fired by the Saudi led military alliance – hit the village of Al-Hajari in the Al Hudaydah governate in Yemen.  
**The attack killed a family of six, among them a pregnant mother and her four children.**  
A blind shell found at the blast site indicate that an guided missile produced by the company RWM Italia S.p.A. – a subsidiary of the German defence company Rheinmetall – was used in the attack.
- Countless victims of the military coalition led by Saudi Arabia and supported by Germany and Switzerland







# JG-Criminal complaints and trial against Heckler & Koch

## April 2010 and 2012: Initial criminal complaint against H&K managers

by Jürgen Grässlin for the illegal export of G36-rifles to forbidden provinces of conflict in Mexiko with the knowledge of H&K executives; several expansions of the criminal complaint

**2012 further complaints by the lawyer Holger Rothbauer against all officials involved in the process at the German control authorities**

## October 2015: Charges filed

by the District Attorney's Office in Stuttgart against former H&K employees, including two former CEOs.

## May 2018 to February 2019: Trial against H&K

before the Stuttgart district court against five former H&K managers for the illegal export of G-36 rifles to Mexiko. **H&K sentenced to a fine of 3.7 mio. Euros, two former employees receive suspended sentences, acquittals for the former CEOs.**

<< For the first time H&K was convicted for an illegal arms deal! >>

## Aktion Aufschrei – Criminal Complaint against SIG Sauer

July 22, 2014: Jürgen Grässlin and Paul Russmann, represented by their attorney Holger Rothbauer, and acting on behalf of the „Aktion Aufschrei - campaign to stop the arms trade”, **file a criminal complaint against leading managers of the small arms producer and export company, Sig Sauer from Schleswig-Holstein.** Some days later the **district attorney's office in Kiel open an investigation** on suspicion of violating the war weapons control act and the federal act on foreign trade. Shortly after, **the government embargoes Sig Sauer's arms exports.**

October 2014: Sig Sauer announce they will from now on only produce sports weapons in Germany. Only 50 jobs are to remain in Eckernförde, most of them moved to the Sig-Sauer factory in New Hampshire, **USA, were the military production is built up.**

February 26, 2019: **Commencement of the criminal trial against Sig Sauer before the Kiel district court.**

April 3rd, 2019: The district attorney's office and the defendants strike a plea deal: **The defendants admit their guilt and expose the details of the illegal arms deal. In turn, they receive suspended sentences and high fines (up to 600'000 Euros). Sig Sauer as a company must pay 11 Million Euros.**




